

RoHS and REACH Compliance Declaration

TouchPoint Medical and iTD Corporation are dedicated to serving you by providing high quality, innovative and intelligent solutions that enable safe and effective delivery of outstanding patient care that meet environmental regulations, including EU Directive 2002/95/EC and subsequent amendments of the European Parliament and of the Council of the use of certain hazardous substances in electrical and electronic equipment (EEE) and REACH (Registration, Authorisation and Restriction of Chemicals, European Union Regulation (EC) 1907/2006).

RoHS Compliance

- We produce parts that are RoHS compliant with the RoHS Directive (EU Directive 2002/95/EC and subsequent amendments) are marked "RoHS Compliant." RoHS Compliance means that the substances restricted by the EU Directive 2002/95/EC and subsequent amendments up to RoHS 3, Directive 2015/863 are not contained in a finished product above the threshold limits stated unless the restrictive substance is subject of an exemption contained in the RoHS Directive. TouchPoint Medical or iTD Corporation cannot guarantee that inventory held by distributors or other third parts is RoHS compliant.
- The compliance of our products with RoHS is affected through:
 - Strictly controlling the materials and finishes that are used in our products,
 - o Periodic audits of our suppliers to ensure compliance,
 - o Periodic analysis, on an as-needed basis, of our products.

REACH Compliance

In June 2007, the European Union Regulation (EC) 1907/2006 concerning the Registration, Evaluation, Authorisation and Restriction of Chemicals (REACH) was first released. This Regulation establishes specific duties and obligations for companies in the European Union (EU) that manufacture or import substances on their own, in preparations, or in articles.

In accordance with the January 2022 amendments and updates to the REACH Candidate List;

- TouchPoint Medical and iTD is a manufacturer and supplier of "articles" to our EU customers. We do not manufacture or supply "substances" or "preparations" and our articles do not involve the intentional "release of substances". Accordingly, we foresee no registration or preregistration requirement for the products we supply to you.
- TouchPoint Medical and iTD believe that even though REACH is an EU regulation, the products are affected in all geographical regions. Therefore, we have put together a team to implement REACH on a worldwide basis.
- TouchPoint Medical and iTD are constantly monitoring the substances of very high concern (SVHCs), as defined by REACH, in our products. This will be an on-going process since the complete list of SVHCs will be amended over time.
